- ☐ Are there ECD Indicator gaps in the 4th MTP Handbook of Indicators and the related CIDPs Handbook of Indicators?



UNFINISHED BUSINESS

- ☐ Beyond the Constitution and other laws, there is need for documentation with precision on which Ministry, Department and Agencies (MDAs) has the mandate to do what in regards to ECD service delivery, as that will help with clarity on which MDAs are to plan and budget for what, at the National and County levels.
 - ☐ For clarity in the current circumstance, there may be need to review most recent Executive Order on the Organization of the Government of the Republic of Kenya, and also the County Specific Executive Orders on Organization of the respective County Governments.
 - ☐ In the context of the Government's Programme Based Budgets (PBB), there is need for clarity on Outcomes and Outputs to be achieved
 - □ Need for clarity and consensus on the priority Indicators to be tracked and reported (at the County and National levels as part of the Non-Financial Information). PBB require that there is clarity on which Indicators and targets are budgets being allocated for, and utilized on.
